- Stephanie Ramsey introduction to John and Michelle Fishpaw – Elevating your Voice Across the Continuum
 - Claire was injured at 11 months was injured by a babysitter
 - Medical support in Columbus and Cincinnati Children’s hospital and used a vast array of resources by the State of Ohio
 - “Clair’s Law” in 2008 was signed by Governor Strickland and became first state in nation to track Shaken Baby Syndrome (SBS) cases
 - Law requires SBS prevention materials to be made available to parents of newborns through hospitals, providers, licensed centers and in home settings.
 - Education is key – inconsolable crying is leading causes of SBS/AHT – most preventable form of child abuse, most expensive due to long-term and complex nature of ongoing treatment
 - Young adulthood, taxpayer resources, expanded on Early Intervention, K-12 Education and Medicaid
 - Education – ourselves and others , Evaluate people and places in whom you entrust, Elevate your voice and advocate no matter the situation

- Data Workgroup – Finalizing report with mechanics, executive summary, and final signoff from Department of Health
- Education and Training Workgroup – Previously working on adding brain injury language on USLME around brain injury and not just concussion through Spencer’s Smith whitepaper. Working on updating goal to target nursing and social work in same fashion.
- Communications Workgroup – Multiple states sharing their advocacy, training
 - Creating a plan on continuing to be present with legislation
 - Modernization language – The Brain Injury Program of Ohio and Brain Injury Advisory Council established by statute by the state. Senator Antani has provided support for the language. Language has lasted 30 years. Do not currently have a lobbyist
- Services Workgroup – Danny Eakins stepped into Services group as Teresa Teeple left. Reviewed pieces of strategic plan with strong emphasis to implement screening into behavioral health field. Increase in training and awareness.

- Passport Administrative Agencies
- CMS Home and Community Based (HCBS) Waivers
 - Medicaid 1915c Waivers – designed to allow states to use a portion of Medicaid money to support individuals living in their community

- Passport Waiver (Department of Aging) and Ohio Homecare Waiver (ohio department of Medicaid)– services include several aspects

Opportunities for Ohioans with Disabilities - Jessica Folsom

Personal Care Assistance – 100 people in the state of Ohio .

- Physical disability that impacts activities of daily living
- Once an individual is eligible, person will receive up to 35 hours, based upon income – will be assigned a reimbursement rate. Maximum reimbursement rate if under \$40,000 a year. About to receive \$13 an hour.
- Person will submit a bill and reimbursed for their time.
