# **Content Template (condition pages)**

The structure of each page, whenever possible, should be as follows. The standard name of the condition should be included at least once. Additionally, if the condition has an alternate name, be sure to include that on the page at least once. Aim to include "Columbus" at least once – instead of "central Ohio."

In general, the ideal total page length should be between 1500 and 2500 words. If this is not achievable based on content available, please aim for at least 500-750 words.
