- Provides education and resources to farmers, agricultural businesses and groups, healthcare, education and disability professionals
- National network of state and regional AgrAbility projects based on US Farm Bill,
 Ohio State University and Easter Seals of Greater Cincinnati
- Staff makes referrals for services which may be able to provide assistance
- Ohio has a 74,000+ farmers specializing in various areas compared to the country –
 7th highest population
- Unique Vocation and Environment workdays, seasonal work, corporate and LLC
- Several injuries related to brain injury TBI, Stroke, Neurological disorders
- Process for helping farmers introduction, farm visit with recommendations, assistance and referrals, work plan implementation, Peer to Peer Network and continued support and education
- Several ways to implement improving specific equipment to make farming safer

Data Workgroup – Finalizing report with mechanics, executive summary, and final signoff from Department of Health

- Education and Training Workgroup Continuing to discuss ways to enhance education in trainings. Joined services to learn more about implementation of TBI-OSU ID
- Communications Workgroup Multiple states sharing their advocacy, training
 - o Continue to discuss ways Ohio can improve communication across the state
 - Modernization language The Brain Injury Program of Ohio and Brain Injury Advisory Council established by statue by the state and language has lasted 30 years. Do not currently have a lobbyist.
- Services Workgroup Continued discussion of focusing on increase in training and awareness. Will need to begin to focus on new discussion of Ohio BRAINS as funding ends in 2023
- Dada Biennial report will be in editing stages. Currently reviewing and will submit data. Amazing work by all individuals involved.

1:03 PM Disorders of Consciousness – Cynthia Beaulieu

- Disorders of consciousness (DOC) seen in fables and legends, modern fiction, modern nonfiction, and discussion on Right-to-Life/Die news articles
- Terry Wallis 19 year "coma"
- What DOC is not brain death, locked-in syndrome, catatonic state
- What is DOC coma, vegetative or unresponsive wakefulness state, minimally conscious state
 - o Distinguishes DOC by wakefulness and responsiveness
- Vulnerabilities: Concern of misdiagnosis, inaccurate prognosis, lack of specialty treatment, lack of specialty access
- Etiologies trauma, vascular, anoxia/hypoxia, infection/inflammation, toxic/metabolic
- Posttraumatic cumulative recovery of consciousness in disorders lasting more than 28 days highlighting progress at 12 months.
- What is available for DoC? Evidence-based and practice guidelines Archives of Physical Medicine and Rehabilitation and Prolonged disorders of consciousness following sudden onset brain injury -national guidelines
- Treatment and services: Typical vs proposed highlighting continuum of care coordination for 2 to 4 months. Specific proposed acute DOC care highlighting inpatient phases for two to four months
- National Campaign "Curing Coma, Awakening Hope"
